The Board of Supervisors convened in adjourned session, members present Chair Creston Schubert, Raymond Drey, and Rhett Leonard

Minutes of the meeting held September 8, 2020 were read and approved.

County Engineer, Jeff Williams presented the Official Secondary Road FY2020 Annual Report. Drey moved and Leonard seconded the motion to approve said report. Motion carried, all voting Aye.

A motion by Leonard and seconded by Drey to approve a public vacation hearing for Dove Ave in Maple Township, Section 14 at 9:30 a.m. and 215th Street in Silver Creek, Section 32 at 10:00 a.m. on October 13, 2020. Motion carried, all voting Aye.

Drey moved to approve and authorize the Chair to sign a Cedar Valley Pay Request at \$254,523.08 for the M31 re-construction project. Leonard seconded the motion and it carried, all voting Aye.

A motion by Schubert and seconded by Drey to approve and authorize the Chair to sign a change order for a decrease of \$423,434.29 for the M-31 reconstruction project. Motion carried, all voting Aye.

Sheriff Wade Harriman was present to discuss an inmate's possible medical claims.

The Tally Lists and Certification of the Precinct Election Officials of the OABCIG Special School Election held on September 8, 2020 were presented and examined by the Board of Supervisors with the results as follows: "Shall Public Measure 47-A be adopted: To authorize a change in the use of money from the penny sales and services for schools received by the Odebolt Arthur Battle Creek Ida Grove Community School District-Ida Grove Precinct Yes-40 votes and No-3 votes; OABCIG District 1-To Fill a Vacancy-Lex Jacobson-39 Votes; Battle Creek Precinct-Yes-22 votes and No-7 votes; Lex Jacobson-24 votes with 2 scattering; Absentee Precinct-Yes 17 Votes and No-2 votes; Lex Jacobson-14 votes. The canvass of the Odebolt Precinct will be September 22, 2020 with final tally results.

Leonard moved to approve and authorize the Chair to sign the FY-20 Tif Report. Drey seconded the motion and it carried, all voting Aye.

A motion by Drey and seconded by Leonard to approve and authorize the Chair to sign a letter to the employees informing them that the County will opt out of the Presidential Directive to defer the payment of employee's social security tax. Motion carried, all voting Aye.

The Board acknowledged receipt of manure management plans from McBride Pork, LLC/Rick McBride; Otter Creek Finisher Farm/Forest Farms, Inc.
