

The Board of Supervisors convened in adjourned session, members present Chair Raymond Drey, Rhett Leonard and Creston Schubert.

Minutes of the meeting held January 26, 2021 were read and approved.

On Tuesday, February 2, 2021 at 4:00 p.m.-The Board of Supervisors met to review the proposed levies. Those present were Chair Raymond Drey, Rhett Leonard and Creston Schubert. Schubert moved to approve the proposed levies and maximum property taxes for FY2021/2022: General Basic Levy-\$3.50 or \$2,181,014 and General Supplemental Levy at \$.34 or \$211,870 and Rural Basic at \$1.27 or \$596,170. Leonard seconded the motion and it carried, all voting Aye. There being no further business, the Board adjourned to meet at 9:00 a.m., Tuesday February 9, 2021.

County Engineer Jeff Williams was present to discuss preparing plans for a possible low water crossing located Section 15 of Silver Creek Township for Dennis Bennett. After much discussion, the Board would like the Engineer to confer with the County Attorney before proceeding.

The current Snow Policy and Mail Box Policy Resolutions were reviewed. The Board requested the Engineer present revised resolutions for their consideration at the next meeting.

At 10:30 a.m., this being the time and place as published for the bid letting of M31 South-IA 39 to IA 175 and D59. PCC Pavement Widening with PCC Resurfacing. Dan Sturm, JEO Consulting and representatives of the following bids were present: Godbersen Smith Construction-\$5,296,195.05; Manatt's-\$5,521,662.66, Croell, Inc-\$5,221,104.93 and Cedar Valley Corporation-\$5,530,279.33. The bids will be reviewed and consideration for approval will be held at the February 23, 2021 meeting.

Ryan Berven representative of Group Benefit Partners was present to review the ISAC Medical/Dental/Vision and Accident plans for FY 2022.

Joe Lageschulte, Weed Commissioner was present to request re-appointment for 2021. Schubert moved and Leonard seconded a motion to approve Joe as Weed Commissioner for 2021 at a rate of \$22.80 per hour. Motion carried, all voting Aye.

Schubert moved to approve Resolution 21-6 Depositories of County Funds. Leonard seconded the motion and it was approved, all voting Aye.

A motion by Leonard and seconded by Drey to approve Resolution 21-7 Assuming Powers and Duties of Douglas Township Clerk, Creston Schubert and Trustees, Rhett Leonard and Raymond Drey. Motion carried with the following vote: Leonard, Aye and Drey, Aye; Schubert abstained. Details of Resolution 21-6 and 21-7 are on file and maybe reviewed at the Auditor's Office or on the idacounty.iowa.gov website.

Schubert moved to approve a \$500 contribution to the Family Crisis Center for FY 2022. Leonard seconded the motion and it carried, all voting Aye.

Sheriff Wade Harriman was present to discuss Public Safety's proposed budget.
