

The Board of Supervisors convened in adjourned session, members present Chair Raymond Drey, Rhett Leonard and Creston Schubert.

Minutes of the meeting held September 1, 2021 were read and approved.

County Engineer Jeff Williams presented contracts from Gus Construction for a Triple Box Culvert in the amount of \$531,659.64 and a Twin Box Culvert in the amount of \$513,369.25 located in Battle Twp., Bridge 109 and 110th in Section 6 on 165th St. Leonard moved to approve and authorize the Chair to sign said contracts. Schubert seconded a motion and it carried, all voting Aye.

Schubert moved to approve and authorize the Chair to sign a Contractors Application for Payment No 3 for Croell, Inc in the amount of \$457,287.96 for the M31:IA39-IA175 Project. Leonard seconded the motion and it carried, all voting Aye.

A motion by Leonard and seconded by Schubert to amend the consideration for the Secondary Road Annual Report. Motion carried, all voting Aye. Schubert moved and Leonard seconded the motion to approve said report. Motion carried, all voting Aye.

Discussion was held on M31:IA39-IA175 cost overruns with regards to 4 miles of widening the road 1 foot on each side. Discussion was also held on future bonding projects. Assessor Joe Cronin presented estimated valuations with regards to Wind Farm #1 and #2.

Veronica McFadden, Consultant from Trusted Energy was present to discuss the utilization of Rescue Plan Funds for solar power to the courthouse.

Matthew Kallsen, Frontier Communications held a webinar concerning bringing fiber optics to the courthouse.

Corey Trucke, EMS Director discussed compensation/training for Medical Examiner Investigators.

Schubert moved and Leonard seconded a motion to approve Provider and Program Participation contracts with Western Iowa Tourism & CAASA. Motion carried, all voting Aye.

A motion by Leonard and seconded by Schubert to approve the ARPA intial report filed by Lorna Steenbock, Auditor on August 19, 2021, including the loss of revenue calculations. Motion carried, all voting Aye.

Schubert moved to approve a salary certification for Kyle Schiernbeck, Jailer in the amount of \$18 per hour, effective September 20, 2021. Leonard seconded the motion and it carried, all voting Aye.

Leonard moved and Schubert seconded a motion to appoint Rita Frahm as a representative to the Regional Housing Fund Board. Motion carried, all voting Aye.
