The Board of Supervisors convened in adjourned session, members present Chair Raymond Drey, Rhett Leonard and Creston Schubert.

Minutes of the meeting held September 28, 2021 were read and approved. It was noted that the October $12^{\rm th}$ meeting was at 9:30 a.m. instead of 9:00 a.m.

County Engineer Jeff Williams presented a payment voucher for Croell, Inc in the amount of \$1,736,716.77 for the M31 project. Schubert moved to approve and authorize the Chair to sign said voucher. Leonard seconded the motion and it carried, all voting Aye.

Discussion was held on repairing the courthouse lawn by delivering some dirt to fill in ruts damaged by Orkin Pest control. Discussion was also held on a possible jake breaking ordinances for Hwy 175 and M31.

Schubert moved to approve and authorize the Chair to sign an Engagement of Northland Securities as underwriter and receipt of related disclosures agreement. Leonard seconded the motion and it carried, all voting Aye.

A phone conference was held with Jeff Heil and Heidi Kuhl with Northland Securities to discuss future bonding, amending the Urban Renewal Plan and reviewed the debt limit. If the County would bond \$10,000,000; the county would be at a projected 75% debt capacity. It was the concensus of the Board to proceed with the \$10,000,000 bond process for a road project, courthouse renovation and bridge projects.

Dawn Mentzer, Rolling Hills CEO was present to update the Board with regards to HF 619. She informed the Board that they will not need to budget for Mental Health next fiscal year, due to the State taking over Mental Health Services. She also reviewed various mental health programs and finances.

A motion by Schubert and seconded by Drey to deny employee compensation for volunteering as a fire fighter during a work schedule. Motion carried, all voting Aye.

Leonard moved and Schubert seconded a motion to approve the Auditor's, Recorder's and Sheriff's quarterly reports. Motion carried, all voting Aye.

A motion to approve the resignation of Judy Andresen as a member of the Ida County Board of Health, effective December 31, 2021 was made by Leonard and seconded by Drey. Motion carried, all voting Aye.

Schubert moved and Leonard seconded a motion to approve the Iowa Dept of Ag, 2022 Scale License renewal in the amount of \$84.00. Motion carried, all voting Aye.

A motion by Leonard to approve Resolution 21-36 Confidentiality of public recordds related to the election infrastructure of Ida County. Schubert seconded a motion and it carried, all voting Aye. Details of Resolution 21-36 are on file and maybe reviewed in the Auditor's Office or on the idacounty.iowa.gov website.

Drey moved to approve and authorize the Chair to sign the Ida County Provider and Program Participation Agreement with Mid-Sioux and Family Crisis Center. Leonard seconded the motion and it carried, all voting Aye.

A motion by Leonard to approve a quote from Solutions, Inc. for a Board Room camera in the amount of \$984. Schubert seconded a motion and it carried, all voting Aye.

The Board acknowledged receipt of manure management plans from RJR Turkey Farm/Roger Mueggenberg; Kreft Turkey Facility/Jeff & Kelly Kreft; R & M Pork/Rick McBride; Dero Schmidt; Faith Site/Gary and Carolyn Nachazel; Noble Finisher Farm/IRC Farms.
