A motion to approve and authorize the Chair to sign an Ida County Secondary Road Dept. and agreement to perform work within Ida County Right of Way from Kevin Schmidt located in Battle Township, Section 33 to clean out the ditch along Carriage Ave. was made by Leonard and seconded by Drey. Motion carried, all voting Aye. Drey moved to approve a claim in the amount of \$12,756.39 from Bluestreak Equipment,
