

Ordinance 31

AN ORDINANCE ESTABLISHING THE COUNTY SUPERVISOR DISTRICTS AND ELECTION PRECINCTS

BE IT ENACTED by the Board of Supervisors of Ida County:

Section 1. Purpose: The purpose of this ordinance is to establish election precincts and County Supervisor districts as the result of the population changes reflected by the 2020 federal decennial census, in accordance with Iowa Code Sections 331.210A and 49.7.

Section 2. Supervisor Districts: WHEREAS, the Code of Iowa stipulates that County Boards of Supervisors shall be organized and operate under one of three enumerated Supervisor plans; and

WHEREAS, Supervisor Plan “Three” was selected pursuant to Section 331.210 at an election held February 24, 1976; and

WHEREAS, the Code provides that following each federal decennial census, the Board shall divide the county into supervisor districts of equal population.

NOW, THEREFORE, BE IT ORDAINED by the Board of Supervisors of Ida County, Iowa, that Ida County, Iowa be and is hereby divided into three supervisor districts as follows:

District #1 – District #1 shall consist of Galva and Griggs Townships. The following portion within Douglas Township-Point of beginning: Brady Ave. and 140th St., west on 140th St. to Alpine Ave., north on Alpine Ave. to 125th St, west on 125th St to the Ida/Woodbury County line, north on Ida/Woodbury line to the Ida/Cherokee County line , east on Ida/Cherokee line to Brady Ave., south on Brady Ave. to 140th St. point of beginning. Population – 2333

District #2 – District #2 shall consist of the following portion within Douglas Township-Point of beginning: US Hwy 20 and Brady Ave., north on Brady Ave to 140th St., west on 140th St. to Alpine Ave., north on Alpine to 125th St, west on 125th St to the Ida/Woodbury County line, south on Ida/Woodbury line to US Hwy 20 (160th St.), east on US Hwy 20 to Brady Ave. point of beginning. Battle, Logan, Maple, Garfield Townships. The following portion within Grant Township-Point of beginning: Garfield/Grant Township line (Faith Ave.) & 290th St., east on 290th St. to US Hwy 59, south on US Hwy 59 to the Ida/Crawford County line (A Ave), Ida/Crawford line west to Garfield/Grant township line (Faith Ave.) north along Garfield/Grant Township line to point of beginning. Hayes, Blaine and Silver Creek Townships. Population – 2338

District #3 – District #3 shall consist of Corwin Township and the following portion within Grant Township-Point of beginning: Garfield/Grant Township line (Faith Ave.) and 280th St, east on 280th St. to US Hwy 59, south on US Hwy 59 to 290th St, west on 290th St. to Garfield/Grant Township line, north on township line to point of beginning. Population – 2334

Section 3. Legal Description of Precincts:

NOW, THEREFORE BE IT ORDAINED by the Board of Supervisors, Ida County, Iowa, that changes in the new precincts shall be established as follows:

1	City of Ida Grove, Ward I. Shall include all that part of the city not included in ward three lying east of a line described as follows: Commencing at the intersection of the centerlines of Main Street and Fifth Street; thence South along the centerline of Main Street to the intersection of South Main Street and the Southernmost portion of Valley View Drive; thence East along the centerline of Valley View Drive to the middle of the intersection of Valley View Drive and Park Lane; thence Southeasterly along the centerline of Park Lane to the corporate limits.	700
2	City of Ida Grove, Ward 2. Shall include all the part of the city not included in ward three lying west of a line described as follows: Commencing at the intersection of the centerlines of Main Street and Fifth Street; thence South along the centerline of Main Street to the intersection of South Main Street and the Southernmost portion of Valley View Drive; thence East along the centerline of Valley View Drive to the middle of the intersection of Valley View Drive and Park Lane; thence southeasterly along the centerline of Park Lane to the corporate limits.	671
3	City of Ida Grove, Ward 3. Shall include all that part of the city located north of a line described as follows: Commencing at the intersection of the West corporate limits of the City of Ida Grove and the center of the Maple River; thence East along the centerline of the Maple River to the point where the centerline intersects the centerline of Badger	963

Creek; thence East along the centerline of Badger Creek to the intersection of Badger Creek and Fifth Street; thence East along the centerline of Fifth Street to the middle of the intersection of Fifth Street and Moorehead Street; thence North along the centerline of Moorehead Street to the middle of the intersection of Moorehead Street and Third Street; thence East along the centerline of Third Street to the intersection where Third, Barnes and East Second Streets meet; thence Southeasterly along the center of East Second Street to the East corporate limits. Corwin Township and the following portion within Grant Township- Point of beginning: Garfield/Grant Township line (Faith Ave.) and 280th St, east on 280th St. to US Hwy 59, south on US Hwy 59 to 290th St, west on 290th St. to Garfield/Grant Township line, north on township line to point of beginning.

6	City of Holstein; Griggs Township and The following portion within Douglas Township- Point of beginning: Brady Ave. and 140 th St., west on 140 th St. to Alpine Ave., north on Alpine Ave. to 125 th St, west on 125 th St to the Ida/Woodbury County line, north on Ida/Woodbury line to the Ida/Cherokee County line , east on Ida/Cherokee line to Brady Ave., south on Brady Ave. to 140 th St. point of beginning.	1781
7	City of Battle Creek; The following portion of Douglas Township-Point of beginning: US Hwy 20 and Brady Ave., north on Brady Ave to 140 th St., west on 140 th St. to Alpine Ave., north on Alpine to 125 th St, west on 125 th St to the Ida/Woodbury County line, south on Ida/Woodbury line to US Hwy 20 (160 th St.), east on US Hwy 20 to Brady Ave. point of beginning. Battle, Logan, Maple, Garfield Townships. The following portion within Grant Township-Point of beginning: Garfield/Grant Township line (Faith Ave.) & 290 th St., east on 290 th St. to US Hwy 59, south on US Hwy 59 to the Ida/Crawford County line (A Ave), Ida/Crawford line west to Garfield/Grant township line (Faith Ave.) north along Garfield/Grant Township line to point of beginning.	<u>1626</u>
