

Ida Grove, Iowa  
January 11, 2022

The Board of Supervisors convened in adjourned session, members present Chair Raymond Drey, Creston Schubert and Rhett Leonard.

Sam Bennett, Pheasants Forever President was present to discuss 105 acres of land that is for sale west of Crawford Creek. They are exploring various funding sources for the possible purchase of the land and establish a possible wild life refuge for Crawford Creek.

Minutes of the meeting held January 3, 2022 were read and approved.

County Engineer Jeff Williams updated the Board on various road projects and funding for the upcoming fiscal year.

At 10:00 a.m., this being the time and place as published, Chair Drey opened the public hearing on a proposal to enter into a Courthouse Loan Agreement in the amount not to exceed \$2,000,000. At 10:10 a.m. Chair Drey closed the public hearing. There was no one present and no objections were filed.

At 10:15 a.m., this being the time and place as published, Chair Drey opened the public hearing on a proposal to enter into an Infrastructure Loan Agreement in the amount not to exceed \$8,000,000. At 10:25, Chair Drey closed the public hearing. There was no one present and no objections were filed.

Leonard moved and Schubert seconded a motion to approve and authorize the Chair to sign Resolution 22-03 Taking Additional Action on Proposals to enter into General Obligation Loan Agreements, combining Loan Agreements and authorizing the use of preliminary official statement in connection therewith.

Ryan Berven, Group Benefit Partners was present to review the ISAC Health/Dental/Vision and Accident Insurance.

A motion by Leonard and seconded by Schubert to approve the adjusting resignation date to February 11, 2022 for Rebecca Schmidt, Civil Deputy. Motion carried, all voting Aye.

Leonard moved to approve and authorize the Chair to sign the Siouxland Regional Transportation Services agreement with the City of Ida Grove in the amount of \$5,205. Schubert seconded the motion and it carried, all voting Aye.

Schubert moved and Leonard seconded a motion to approve a salary increase for Joe Hogan, Driver's License in the amount of \$16.00 per hour effective January 18, 2022. Motion carried, all voting Aye.

A motion by Schubert was made to approve the Auditor's, Recorder's and Sheriff's Quarterly reports. Leonard seconded the motion and it carried, all voting Aye.
