**NOTICE TO VOTERS**-November 8, 2022 General Election

**\*\*VOTER REGISTRATION INFORMATION:** You must be registered to vote to participate in the General Election.

Registration may be done in the following ways:

**Register in Person** in the Auditor's Office, 401 Moorehead St., Ida Grove, IA 51445. You may **mail your registration** to the Auditor's office—which must be received or postmarked by October 24, 2022. Registration forms are available on the <https://sos.iowa.gov> website. **Register online** at <https://sos.iowa.gov> website. **Pre-Registration deadline is 5:00 p.m., Monday, October 24, 2022.**

**Election Day Registration.** You may register in person at the Auditor's Office prior to November 8, 2022 or at your polling place on Election Day by presenting a current photo ID which include-Iowa or Out of state driver's license or non driver ID card, US passport, US Military ID or Veteran's ID, ID card from an employer, Student ID issued by Iowa high school or college or Tribal ID Card/Document and proof of residency which must include name and current address and be current within 45 days, may be in an electronic format or on paper-Residential lease, Utility bill, including cell phone bill, paycheck, property tax statement, bank statement, government check or other government issued document to the election officials.

**\*\*ABSENTEE VOTING IN THE AUDITOR'S OFFICE:** Absentee ballots will be available on Wednesday, October 19, 2022 at the Ida County Auditor's Office and may be voted in the office until 4:30 p.m. Monday, November 7, 2022.

**ABSENTEE BALLOTS BY MAIL:** A ballot may be mailed to you upon receiving your request. Requests can be made in writing ( you must include your name, ID#/Driver's License or 4 digit pin, registered address, date of birth, name and date of election, mail to address if different from registered address and signature and date. Official ballot request forms may be obtained by contacting the Auditor's Office-712-364-2626 or use the one below or copy one on the <https://sos.iowa.gov> website. Requests must be received by the Auditor's Office no later than 5 p.m. on Monday, October 24, 2022.. **Absentee Ballots** must be returned to the Auditor's Office no later than 8:00 p.m. on Tuesday, November 8, 2022. Postmark dates DO NOT count. Absentee Ballots CANNOT be placed in the drop box outside of the Courthouse. **EXTENDED OFFICE HOURS** will be Monday, October 24, 2022 -8:00 a.m.- 5:00 p.m.; Friday, November 4, 2022-8:00 a.m.-5:00 p.m. and Saturday, November 5, 2022-9:00 a.m.-5:00 p.m. For more information contact-Ida County Auditor's Office-712-364-2626 or e-mail [lsteenbock@idacountyia.us](mailto:lsteenbock@idacountyia.us) or idacounty.iowa.gov website or <https://sos.iowa.gov> website.
