

The Board of Supervisors convened in adjourned session, members present Chair Raymond Drey and Rhett Leonard. Creston Schubert was absent.

Minutes of the meeting held October 4, 2022 were read and approved. It was noted that the October 11 meeting started at 9:30 a.m.

County Engineer Jeff Williams presented the updated salary certifications as follows which included the approved \$1.50 per hour increase.
