Whiteing moved to approve and authorize the Chair to sign Change Order #21 from L & L Builders in the amount of \$2191 for painting window walls and heating units. Drey seconded the motion and it carried, all voting Aye.

A motion by Drey and seconded by Whiteing to approve Brandon Bollmeyer, Deputy Sheriff at a rate of \$26.83 per hour, effective June 3, 2023. Motion carried, all voting Aye.

Whiteing moved to approve Resolution 23-20 Amended FY-23 Appropriations. Drey seconded the motion and it carried, all voting Aye.

A motion to approve Resolution 23-21 Tax Abatement for Windstream Communications for Tax Year 2021 was made by Whiteing and seconded by Drey. Motion carried, all voting Aye. Drey moved and Whiteing seconded to approve Resolution 23-22 Allocating American

Rescue Plan Funds. Resolution carried with all voting Aye.

OABCIG Superintendent Matt Alexander was present along with County Engineer Jeff Williams, Asst. County Engineer Colin Ryan, Ida Grove City Mayor Nathan Weitl, City Clerk Heather Sweeden and Gerrod Sholty, foreman with the City Crew. A discussion was held regarding road issues in and/or near the OABCIG High School ball fields. Dust control and safety were the top priorities. The consensus was that 255th Street is the counties responsibility, and that Keystone Ave. is shared responsibility, 50/50, City of Ida Grove and Ida County. Williams will get cost estimates, for several options, City and School parties will do research on the project and continue the conversation in a future meeting in order to address the issues brought before the Board.

Drey moved to accept the bid, Whiteing seconded the motion. The motion carried, all voting Aye.
