A motion to approve minutes from January 27, 2026, by Schubert, seconded by Whiteing. Motion carried all voting Aye. There were no public comments to the board.

Sheriff Wade Harriman met with the board to discuss Backing the Blue and Sheriff wages.

A motion to approve Treasurer's monthly report by Schubert, seconded by Rohlk. Motion carried all voting Aye.

A motion by Whiteing to approve FY2027 health plans; to keep the current plans for FY27, seconded by Schubert. Motion carried
